That after receipt of report submitted by Inspecting Officers, the Hon'ble D.G.S.E., Punjab is pleased to accord his approval under the provisions of section 18 of Free & Compulsory Education Right to Children Act, 2009 and under rule 11 of Free & Compulsory Education Right to Children Act, 2009 vide his letter No. D.G.S.E/R.E.E./2016/1276-78 DATED 25/01/2016 for issue of 'Certificate of Recognition' from Class Pre-Nurturery to Class VIII being run by Maharaja Ranjit Singh school, Tarn Taran subject to the compilation of following terms and condition .

1. That organization/school will not charges any un-authorized fees neither any child nor his/her parents will by any means be discriminated.
2. That the admission in the school will not be denied on the pretext of non-production of 'Birth Certificate 'and such cases if he/she produces the said certificate within such extended period, the admission to school" will not be refused on the basis of religion/caste/place of birth and the authorities will compile with the instructions contained in section 15 of the above said Act.
3. That no child will be suspended from the school untill he/she completes his/her primary school education.
4. That no child will be given capital or mental punishment.
5. That the child who has completed his/her primary school education will be issued with a certificate as per section 31 of Free & Compulsory Education Right to Children Act, 2009.
6. That the school authorities will furnish 'Building Safety Certificate, Fire Safety Certificate' from time to time alongwith other required documents for the renewal of 'Certificate of Recognition' and copy of above mentioned certificates will be handed over the District Education Certificate (S.S.) Tarn Taran and in case of failure to do so; the

necessary action will be initiated to cancel 'Certificate of Recognition' under the provisions of R.T.E. Act.

7. That the school buildings or other structures or the grounds are used only for the purposes of education and skill development.
8. That it is necessary that the teachers appointed conform that they possess education as laid down under section 28 (10 of R.T.E.
9. That the school authorities will conform to the instructions issued by Department of Education and the remaining instructions will also be compiled with as per Temporary Certificate of Recognition. The School have the Recognition Code No. R.T.E. Tarn Taran – 19080359..
10. That the school authorities will conform to the instructions as laid down in The Punjab Regulation Institution Act, 2016 (Punjab Act No. 47 of 2016).
11. The school/organization will conform to the instructions as laid down in R.T.E. 2009 and in case if it comes to notice that school/organization has failed to do so, the 'Certificate of Recognition' will be cancelled.
